Regulatory duty on 441 import items revised

The Federal Board of Revenue (FBR) has revised regulatory duty (RD) on the import of 441 items from June 21, 2017. According to an SRO 505(I)/2017 issued on Wednesday by the FBR, in exercise of the powers conferred by sub-section (3) of section 18 of the Customs Act, 1969, the Federal Government has amended S.R.O.568 (I)/2014 dated the 26th June, 2014 pertaining to the RD.

Sources said that the FBR has increased RD by 5 percent on many items already subjected to regulatory duty. Overall, RD has been revised upward on 441 items through SRO 505(I)/2017. The FBR has also specified PCT code, name of item, description of item and new rate of RD.
